## 7. Submission of Quotations

Quotations should be deposited in the Quotation/Bid box at Ministry of Education Building, at Ministry of Sport, Youth and National Service, **Second Floor**, Room 243, Government Office Park, Luther Street, Procurement Management Unit, Windhoek, not later than **11h00 on Tuesday, 24 February 2026**. **Quotations received via email will be rejected.**

## 8. Opening of Quotations

Quotations will be opened internally by the Ministry immediately after the closing time referred to in instruction 7 above. A record of the Quotation Opening stating the name of the bidders, the amount quoted, will be posted on the website of the Ministry and available to any bidder on request within three working days of the Opening.

## 9. Evaluation of Quotations

The Public Entity shall have the right to request for clarifications in writing during evaluation. Offers that are substantially responsive shall be compared on the basis of price or ownership cost, subject to Margin of Preference where applicable, to determine the lowest evaluated quotation.
