The Ministry of Education, Innovation, Youth, Sports, Arts and Culture reserves the right:

10. Opening of Quotations

Quotations will be opened internally by the Ministry of Education, Innovation, Youth, Sports, Arts and Culture immediately after the closing time referred to in section 9 above. A record of the Quotation Opening Report stating the name of the Bidder, the total amount, any discount or alternative offered, the presence or absence of a Bid-Securing Declaration, Written Undertaking and compliance with Mandatory Documents (Section 50 (2)) will be put on the notice board of the Ministry of Education, Innovation, Youth, Sports, Arts and Culture and available to any bidder on request within three working days of the Opening.

11. Evaluation of Quotations

The Ministry of Education, Innovation, Youth, Sports, Arts and Culture shall have the right to request for clarifications in writing during evaluation. Offers that are substantially responsive shall be compared on the basis of evaluated cost to determine the lowest evaluated quotation

12. Scope of Services and Performance Standards

The Scope of Services, Specifications and Performance standards detailed in Sections III and V are to be complied with.

13. Price and Currency of Payments

Quotations shall be fixed in Namibian Dollars and all payments will be made in this currency. Quotations shall cover all costs of labour, materials, equipment, overheads, profits and all associated costs for performing the services, and shall include all duties. The whole cost of performing the services shall be included in the items stated, and the cost of any incidental services shall be deemed to be included in the prices quoted.

14. Labour Clause
